

APPLICATION TO TRAIN and JOIN FE TEAMS

Freedom Encounters, Inc. (Rev. 11/23)

Qualification Requirements:

- Know from the Lord Jesus Christ that He has called you to serve His people by ministering deliverance and healing.
- 2. Agree to **learn what is involved with FE ministry** by reviewing the information on the FE website (<u>www.freedomencounters.com</u> WHAT WE DO >> TEAM TRAINING OVERVIEW that defines the specific steps of preparation before ordering team training materials.
- 3. Agree to **learn and complete all preparation steps** listed in the WHAT WE DO >> PERSONAL MINISTRY >> DESIRE MINISTRY sections of the FE website, including completing the <u>Victory Over Spiritual Conflict</u> seminar and accompanying teaching manual.
- 4. Agree to **view** the teaching <u>and</u> testimonial **videos** and **learn** the information contained in the "**FAQs**" and "**Preparation Overview**" documents (see Desire Ministry steps).
- 5. Agree to **receive the FE deliverance and aftercare prayer ministry appointments** from a <u>qualified</u> FE team member for yourself. Agree to regularly practice using the FE aftercare tools provided after your ministry appointment.
- 6. Read the **Teaching** information on the website and **complete the Deliverance Procedures and Aftercare seminar training**.
 - a. Attend an in-person seminar, or purchase Flash Drive media to train by watching videos.
 - b. Listen to the DP and Aftercare Ministry seminar teaching a second time.
- 7. Agree to schedule and receive **two deliverance and two aftercare coaching sessions** by an authorized **FE Coach**. (Our trained coaches follow the FE ministry approach carefully. Over an extended time, they have proved by example to be experienced, skilled and trustworthy.(A fee will be paid to the FE Coach).

Coaching Requirement Explanation:

People may wonder why we have established new teammate training to include mandatory coaching of two sessions, each of the <u>Deliverance Procedures</u> and <u>Aftercare</u> ministry appointments. There are two main reasons: 1) Holy Spirit directed us to do that many years ago. 2) Learning about a topic is only one piece of education. Another critical component is for an individual to apply the topic studied so that they may gain invaluable experience and wisdom beyond what they could ever anticipate.

Many decades of ministry have trained us well! We **KNOW** that support and mentoring are vital keys to instill successful teaching and training. We want to ensure that our approved trainees will not only be READY to minister using FE's tools and procedures but will also feel CONFIDENT as they go forward hand in hand with Holy Spirit as they minister.

- 8. Once released by your FE Coach, you agree to **pray the FE Deliverance and Aftercare procedures as taught, according to the language written in the most current versions.** You agree that there will no mixing of other ministry approaches or tools <u>during FE ministry</u>.
- 9. Agree to follow the minister the content of the "**DP Aftercare Ministers' Procedures**" within 3-7 days following the client's deliverance appointment, and b) to provide a copy of the "**Aftercare**. **Guide to Encounter JESUS**" document to the client. If desired, the aftercare session may be recorded, using the client' phone.
- 10. Agree that a Scribe will be available to take notes for the client receiving deliverance ministry and the deliverance ministry appointment will never be recorded. Agree to enlist an **intercessor** to pray as you minister deliverance (does not need to be present); and whenever possible, try to enlist. caring friends to provide help if necessary.
- 11. Agree to **submit to the leadership support and mentoring** of the person or team that God has established for your location/region and to **provide immediate feedback of new revelation or questions if** encountered during the ministry.
- 12. Agree to **stay current with new revelation** as outlined in the Freedom Encounters Team letters.
